LOCATION

Carnlough is a charming coastal village in the heart of the Glens of Antrim, a designated area of outstanding natural beauty. It sits at the foot of Glencloy, the second of nine Glens.

The Hotel is positioned on the iconic Causeway Coastal Route, about an hour from two of Ireland's main tourist attractions, the UNESCO Giant's Causeway and Belfast's Titanic Museum.

Carnlough is also about an hour from Royal Portrush Golf Club an only 30 minutes from Galgorm Castle Golf Club.

The hotel overlooks the picturesque harbour which is the focal point of the village and which in recent years was one of the locations used in Game of Thrones.

The area's treasure trove of natural beauty includes the Cranny Falls waterfall and Carnlough beach, both within walking distance of the Hotel.

THE HISTORY

Built in 1847 as a Coaching Inn by Frances Anne Vane Tempest the Marchioness of Londonderry. The Marchioness 'legacy is still evident -she commissioned Carnlough's townhall, railway track, bridge and its protected harbour. Following her death the property was inherited by Sir Winston Churchill, a globally significant historical figure.

Since 1947 the Hotel has been owned by the O' Neill family. The Londonderry Arms is one of the longest established family Hotels in Ireland. The family sympathetically extended and restored the Hotel retaining its original features and maintaining its unique character throughout. A five bay wing built around 25 years ago ,with its vaulted ceilings ,exposed beams and open fires ,blends seamlessly with the original Georgian building.











DESCRIPTION

The subject comprises a Georgian two-storey three-bay building with five-bay annex to the rear. The building has a Bangor blue slate roof, timber sliding sash windows, Tuscan columns, and ornamental plasterwork.

The hotel benefits from a range of elegant original features including open fires and vaulted ceilings. There is also a modern lift providing access to the first and second floor.

In addition there is a substantial former Church Hall at the rear of the property which would be suitable for redevelopment (subject to the necessary planning consents).

Externally there is a carpark laid in tarmac facing the hotel providing space for over 20 cars as well as an enclosed boiler house immediately east of the hotel.

The hotel is B2 Listed (HB Ref No: HB06/01/008).

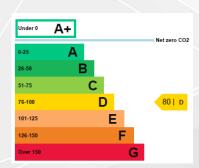
